Description

Arborfield and Newland Parish Council owns one of the best public park and recreation facilities in the Borough of Wokingham. Recently the pavilion at the park has undergone a long overdue partial refurbishment to become the home of a new Montessori nursery and provide upgraded and improved facilities for local residents.

A further refurbishment and extension of the pavilion is now planned. This is the final phase of the planned work and includes the upgrade of the facades and replacement of the windows and doors not undertaken during the previous work and, the construction of a new single storey extension that will match the existing building to provide new sport changing and showering facilities and a parish office.

Invitation & Criteria to Tender

We invite companies who feel they are able to meet the Parish Council's criteria (listed below) to bid for the main construction element for this project, Using the project reference "A&NPC-PP2-Main Build".

- Any company bidding for work in excess of £25k must be able to provide:
 - Details of their registered office, company number, shareholders, and directors.
 - Confirmation of a minimum of £1 million of public liability insurance secured on an each and every claim basis.
 - o A bond, secured under seal, if requested.
 - o A full copy of their H&S policy, qualifications, and credentials.
 - o Examples of relevant experience, and references if required.
- In addition to the above any company bidding for this work must:
 - Make the application, liaise, and manage the "Building Control" regulations process.
 - o Be able to commit to start on site by no later than Monday 2nd October and work continuously on the project thereafter, in order that the build is completed a.s.a.p.
 - Undertake a full buried services check prior to the commencement of any demolition or excavation work.
 - Provide a designated full-time on-site foreperson must be provided at all times.
 - o Provide full site security fencing, with secure storage, toilet, and welfare facilities.
- The parish council is very aware of the responsibilities it holds in ensuring the minimisation of the
 carbon footprint impact it causes for projects of this type. As a result, an element of preference
 will be considered in selecting a successful bidder for any company who can demonstrate how
 they will help the parish council achieve their objective.
