ROAD TRAFFIC REGULATION ACT 1984

WOKINGHAM BOROUGH COUNCIL

(VARIOUS ROADS, WOKINGHAM BOROUGH)

(TEMPORARY PROHIBITION OF DRIVING) ORDER 2023

NOTICE IS HEREBY given that Wokingham Borough Council as Traffic Authority proposes to make an Order under Section 14 (1) (a) of the Road Traffic Regulation Act 1984 the effect of which is to prohibit any vehicle from proceeding along:

1. Link Way, Arborfield between its junctions in either direction with School Road and B3030 Eversley Road.

The alternative route for all vehicles affected this restriction will be via School Road and B3030 Eversley Road or by this route in reverse.

2. St Patricks Avenue and Kingsley Close, Charvil

The alternative route for all vehicles affected by these restrictions will be via Park View Drive North.

3. Mansfield Road, Wokingham

The alternative route for all vehicles affected by Item 6 shall be via Heelas Road, Meadow Road and Woosehill Lane, or by this route in reverse.

4. St James Road, Finchampstead between its junctions in either direction with Barkham Ride and Roycroft Lane.

The alternative route for all vehicles affected by this restriction shall be Barkham Ride, Nash Grove Lane and Roycroft Lane or by this route in reverse.

5. Rushey Way, Earley between its junctions in either direction with Carshalton Way and B3270 Lower Earley Way.

The alternative route for all vehicles affected by this restriction shall be via Carshalton Way and B3270 Lower Earley, or by this route in reverse.

6. Nine Mile Ride, Finchampstead between its junctions in either direction with New Wokingham Road and Lower Wokingham Road.

The alternative route for all vehicles affected by this restriction shall be via A321 Lower Wokingham Road, B3348 Dukes Ride and New Wokingham Road or by this route in reverse.

7. Wiltshire Avenue, Crowthorne between its junctions in either direction with Ellis Road and B3348 Dukes Ride.

The alternative route for all vehicles affected by this restriction shall be via Ellis Road, The Avenue and B3348 Dukes Ride, or by this route in reverse

- 8. Riding Way, Wokingham from its junction with Somerset Close
- 9. And from proceeding along the following:

Works requiring these restrictions are expected to take place from the 14th November 2023. Further communications will be sent when individual locations have been planned.

The reason for these prohibitions is to allow Wokingham Borough Council contractors to undertake Structural Maintenance including Carriageway Patching, Plane Inlay Resurfacing, Micro Asphalt Resurfacing, Surface Dressing, Rejuvenator works and associated work in safety.

Access for residents and businesses within the boundaries of these restrictions will be maintained but there may be some instances when access will be delayed.

The restriction imposed by the Order shall only apply during those periods when traffic signs complying with the Traffic Signs Regulations and General Directions 2016 are lawfully displayed.

The restrictions contained in the Order shall come into operation on the 14th November 2023 and shall continue in force for a period not exceeding 18 months or until the works have been completed, whichever is the earlier.
