 - 1. **Ionos (includes domain name)** Standard £6/month, Plus £9/month or premium £16/month (there is an offer on for the first year sign up, which makes the packages half price for the first year). All prices exclude VAT.
 - 2. Name Cheap (Domain name not included) Stellar £3.52/month, Stellar Plus £5.09/month or Stellar business £7.45/month (discounts available for first year subscription of between 47% and 67% depending on the option taken out) All prices exclude VAT.
 - 3. **Fasthosts** (**includes domain name**) Start £5/month, Grow £7/month or Scale £12/months (discounts available for first 6 months subscription) All prices exclude VAT.
 - 4. **Bluehost (includes domain name)** Basic £3.13/month, Choice plus £7.05/month or Online Store (selling site) £12.54/ month (Discounts available for initial term of subscription) All prices exclude VAT
